The guidelines observed for the preparation of gradation list of Cashiers are as follows:

1. The incumbents recruited through KPSC (General/Special) shall be determined by the effective date of advice of the KPSC.
2. The incumbents appointed under Compassionate Employment Assistance Scheme shall be determined with respect to the date of joining duty.
3. The incumbents appointed under Sports Quota shall be determined with respect to the Board Order provided the appointment is within the quota fixed for them.
4. The incumbents those who have been granted extension of joining time beyond 90 (ninety) days from the date of appointment order shall be determined from the date of joining duty.
5. The seniority of those who have availed LWA as per Appendix XII A, B and C of Part I, KSR before declaration of probation shall be determined from the date of rejoining duty.
6. The seniority of promotees to the cadre of Cashier shall be determined by the date of promotion order. The relative seniority is fixed in the order in which their names are arranged in the respective promotion order.
7. The seniority of differently abled recruits shall be determined with reference to the date of reappointment in the cadre.
