Sub:- Establishment – Promotion of Junior Assistants/Cashiers to the cadre of Senior Assistant – orders issued.

ORDER

The following Junior Assistants/Cashiers (list appended) are promoted to the cadre of Senior Assistant. All the promotions will be purely provisional subject to the following conditions.

1. The promotions ordered are purely provisional as per relevant Rules in KS & SSR 1958 and as adopted by the Board and without prejudice to the claims of the seniors, if any. The incumbents shall complete probation in the cadre of Senior Assistant.
2. The above promotions are ordered in the exigency of service and in public interest.
3. The above promotions are ordered from among eligible applications of candidates qualified as on 01.08.2022 against vacancies occurred as on that date in pursuant to this office notification read 1st paper above.
4. Name and date of birth of promotees shall be verified with their Service Books and if any discrepancies are noted, the promotions shall not be effected and the fact shall be reported to this office immediately. It should also be ensured that there is no adverse remark in the Service Book of the promotees barring their promotions.
5. The controlling officers are strictly instructed to ensure that the probation of the promotees in the cadre of Junior Assistants/Cashiers have been declared as on the date of notification above dated 01.08.2022 otherwise the promotion shall not be effected.
6. The ARU Head shall make necessary internal arrangements within their jurisdiction so that cashiers under orders of promotion are relieved at the earliest without interruptions in the revenue collection process. However, the promotion of candidates who are not relieved for want of substitute shall be effected, provided other conditions mentioned above are satisfied and they shall be allowed to attend the cash collection until substitute join duty.
7. The promotion in respect of those who are placed under suspension/on LWA as per Appendix XII A,B & C Part I KSR shall not be effected and such cases shall be intimated to this office.

8. Promotions of those cashiers who have availed joining time for more than 90 days during entry of service in KSEBL shall report and obtain sanction from Chief Engineer (HRM) before effecting the promotion.
9. If any promotee who have accepted time bound grade promotion in the scale of pay attached to the cadre of Senior Assistant and above, fails to accept promotion, he/she will be deemed to have not accepted promotion on his/her own volition which will entitle the forfeiture of the promotion now ordered and also the time bound grade promotion in the scale of pay of Senior Assistant and above sanctioned to him/her and he/she will not be eligible for the entire monetary benefits that arose out of such grade promotion and the same will be recovered from him/her in lump.
10. The ARU Heads concerned shall take immediate necessary steps in liaison with the office of the undersigned to release the withheld promotions of the incumbents under their control.
11. Provisions of KSR will govern the fixation of pay in respect of the promotees.
12. The promotees shall compulsorily attend the training programme as stipulated in the training policy of KSEBL
13. As per Board Order read 4th paper above, the promotees who were appointed as Cashiers under 10% in-service quota vide this officer order read 2nd & 3rd above and who were not qualified the Departmental test conducted by KPSC shall fulfill the following.
 - (a) *They should successfully complete three months orientation training programme including on-the-job training and class room training conducted by KSEBL with in the probation period.*
 - (b) *The successful completion of three months orientation training programme is a per-requisite for the completion of probation period in the category of Senior Assistant.*
14. The concerned ARU should monitor the 13th condition above before the declaration of their probation in the cadre of Senior Assistant.
15. The promotions of following incumbents are withheld for want of per-requisites remarks against each for considering promotion.
