ORDER

As per the Order read as 1st paper, Kerala Service Rules was made applicable to the Board and as per the Board Order read as 2nd paper, the provisions of Kerala State & Subordinate Service Rules, 1958 was also made applicable to the Board. Subsequently, as per communication No. Dis. 8914/68 dated 17-08-1968, Board resolved that the amendments issued to Kerala Service Rules by Government will not automatically apply to the Board employees unless the amendments are specifically ordered to be adopted by the Board in view of these existing orders, the Board has been adopting or ignoring amendments to Kerala Service Rules and Kerala State & Subordinate Service Rules issued from time to time. This has posed serious problems including observation by Audit. Therefore, Board felt that there is need to bring the provisions of Kerala Service Rules and Kerala State & Subordinate Service Rules and their amendments from time to time automatically applicable to the Board, unless decided otherwise and except in cases where they are governed by special regulations of the Board.

2. Therefore, the Board has decided to make applicable Kerala Service Rules and Kerala State & Subordinate Service Rules and their amendments from time to time to the employees of the Board automatically unless otherwise decided by the Full Board and except in cases which are governed by the following rules and order accordingly.

- (i) Kerala State Electricity Board (Classification, Control & Appeal) Regulations, 1969.
- (ii) Kerala State Electricity Board (Employees Disciplinary Proceedings Tribunal) Regulations, 1969.
- (iii) Kerala State Electricity Board (Secretariat Service) Regulations.
- (iv) Kerala State Electricity Board (Conduct of Legal Affairs) Regulation, 1968.
- (v) Kerala State Electricity Board (Meetings) Regulations, 1957.

3. The Order No. Dis. 8914/68 dated 17-08-1968 in which it was ordered that the amendments issued to Kerala Service Rules by Government will not automatically apply to the Board employees unless the amendments are specifically ordered to be adopted by the Board is hereby cancelled.
