## <u>ORDER</u>

As per the Office Memorandum read as 1 <sup>st</sup> paper above, the Department of Pension and Pensioner's Welfare has clarified that in all cases where the Central Government Civil employee has been appointed against a post or vacancy which was advertised/notified for recruitment/appointment, prior to the date of notification for National Pension System i.e, 22.12.2003 and is covered under the National Pension System on joining service on or after 01/01/2004, may be given a one-time option to be covered under the CCS (Pension) Rules, 1972 (now 2021).

2. The Director General of Police cum State Police Chief vide letters read as  $2^{nd}$ ,  $3^{rd}$ ,  $4^{th}$ ,  $5^{th}$  &  $6^{th}$  papers above, forwarded the options submitted by the following officers for switching over from the National Pension System to the Old Pension System, who were appointed against the posts which were notified for recruitment/appointment prior to the date of notification for National Pension System on System i.e. 22.12.2003 and are covered under the National Pension System on joining Indian Police Service after 01/01/2004.

Subsequently, the Department of Personnel & Training, Government of India, vide letter read as 7<sup>th</sup> paper above, has instructed that the AIS officers who have been appointed against a post/vacancy which was advertised/notified for recruitment prior to the date of notification of NPS (ie 22.12.2003) and who are covered under NPS on joining service on or after 01/01/2004 may be granted one-time option to be covered under the provisions of old pension system under All India Services (Death-Cum Retirement Benefits) Rules, 1958.

The Government have examined the matter in detail and are pleased to accord sanction to the below mentioned officers to switch over from the National Pension System (NPS) to the Old Pension System (OPS), covered under All India Services (Death -Cum Retirement Benefits) Rules, 1958 as per the Government of India instructions read as 7<sup>th</sup> paper above.
