ORDER

The appointment of dependents of KSEBL employees who die-in -harness is governed by the orders read as 1st to 6th above. The Chief Engineer (HRM) as per note read as 15th above has forwarded the Verification Statement of 18 dependents nominated for the post of Office Attendant II featured in nomination lists from 10/2020 to 03/2021 who could not be included in the Select Lists, for which the proposals had been submitted as per notes read as 7th to 12th above, for want of vacancy in that cadre. The Chief Engineer (HRM) has intimated as per note read as 13th above that 26 vacancies arose as on 31.07.2023. Consequently sanction for the appointment of 8 (Eight) candidates nominated for the posts

of Office Attendant II from the nomination list of 9/2020 were made as per B.O. read as 14th above. Now, there are 18 vacancies in the cadre which is enough to accommodate as many number of dependents nominated for the post of Office Attendant II.

The matter was placed before the Full Time Directors as per note read as 16th above.


