ORDER

KSEBL as per B.O. read as 1st above revised the norms on the existing 20% in-service quota by transfer to Junior Assistant / Cashier of Lower Grade Employees by granting 10% in-service quota for appointment to the post for employees with pay scales below that of JA/Cashier having SSLC or equivalent qualification on the basis of seniority without suitability test; and the remaining 10% for employees with pay scales below that of JA/Cashier having SSLC or equivalent qualification with suitability test.

An amendment was proposed in the above B.O., in order to consider the employees belonging to the cadre of Office Attendants alone for 10% in-service by transfer appointment to the cadre of Junior Assistant/Cashier without suitability test. As per B.O. read as 2nd, it was ordered to constitute a three member committee with Director (Finance and HRM) as Chairman, Government Representative and an external subject expert as members to examine the amendment proposed in 20% in-service quota in

appointment to the cadre of Junior Assistant/Cashier.

The Additional Chief Secretary to Government, Power (A) Department, as per letter read as 3rd, informed that the Joint Secretary, P&AR (Rules) Department has been nominated to be the representative in the committee to be constituted to examine the above proposed amendment. Also Dr. K S Chandrasekhar, Senior Professor and Chairman - BOS, University of Kerala, who is also the Subject Expert in the Departmental Promotion Committee (Higher) for Ministerial Officers, was identified as the External Subject Expert.

The matter was placed before the Full Time Directors as per note read as 4th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 07.04.2025 & 08.04.2025, resolved to constitute a committee with the following members to examine the amendment proposed in the 10% in-service quota for by-transfer appointment of Office Attendants to the cadre of Junior Assistant/Cashier without suitability Test.

2. Joint Secretary to Government, P&AR (Rules) Department - Member
3. Dr. K.S Chandrasekhar, Senior Professor and Chairman - BOS, University of Kerala - Member


