- Ranked list will be prepared for the above Districts in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said Ranked list will continue to be in force till the publication of a new Ranked list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against aforesaid vacancy and also against the vacancies, if any, reported during the currency of the Ranked list.
  - Candidates should submit applications for the post to any one of the above district and should note the name of that district against the relevant column in the online application. Applications should not be submit to more than one district in response to this notification. If applications are submitted contrary to the above direction, any if he/she is selected, his/her name will be removed from the ranked lists and disciplinary action will be taken against him/her.
  - The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in GO (MS) No.154/71/PD dated 27/05/1971. A candidate advised for appointment in one revenue District from the Ranked List prepared is

not eligible for transfer to another District unless he/she completes five years continuous service from the date of commencement of service in the former District. Even if transfer is allowed after five years, it will be subject to the rules in G.O. (MS) No.36/91/PD dated 02.12.1991. Candidates already in Government service holding the same post in any one District are prohibited from applying again for this post, but they can apply to higher/lower posts when notified.

- (iv) In the case of candidates applying for district wise selections in Idukki, Wayanad and Kasaragod districts working arrangement, deputation, transfer and mutual transfer will not be allowed for at least ten years, if they are appointed from the ranked lists of those districts, their promotion will also be limited to those districts. - (v) 4% of the total vacancies reported for the above post shall be reserved for eligible Differently Abled candidates with disabilities as specified by G.O(Rt) No. 136/2025/SJD dated 06.06.2025.

**5. Method of appointment : Direct Recruitment**

**6. Age Limit : 18 - 40.** Only candidates born between 02.01.1986 and 01.01.2008 (both dates included) are eligible to apply for this post, with usual age relaxation to Scheduled Caste and Scheduled Tribes and Other Backward Classes.

**Note:** For concession allowed in upper age limit, subject to the conditions that the maximum age limit shall in no case exceed 50 years, please see Para 2 of the General Conditions under Part II of the Gazette notification.

- (b) Vision : Normal (free from colour blindness)
- (c) Must be Physically fit for outdoor works and physical fitness shall be evaluated by testing poll climbing skill. Candidates must be able to ascend and descend 9m electric pole with in a time limit of 8 minutes. The proficiency of the candidate shall be assessed in a Practical test to be conducted by the Kerala Public Service Commission at the time of selection.

- (2) In addition to the qualifications prescribed in the notification, the qualifications recognized by executive orders or standing orders of Govt. as equivalent to a qualification specified for a post, in the Special Rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post. The copy of the Govt. orders declaring equivalent or higher qualifications shall be produced as and when required by the Commission.

#### 8. Mode of submitting Applications:-

- (a) Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post.

Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the '**Apply Now**' button of the respective posts in the **Notification Link** to apply for the post. Name of the candidate and the date of taking photograph should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking photograph. **Those candidates who are creating a new profile should upload a photograph taken within a period of six months.** There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application, candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is received as provisional and the details cannot be deleted or altered after submission. Candidates are advised to keep printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link '**My Applications**' in their profile. All correspondence with the Commission, regarding the application should be accompanied with the print out of the application. The application submitted not in accordance with the conditions stipulated in the notification will be summarily rejected in due course of processing. Original documents to prove qualification, age, community etc. have to be produced as and when called for. The profile correction made by the candidates themselves or through the office of the Kerala Public Service Commission on request after the last date fixed for the receipt of applications will not be reflected in the application. Such corrections will come into effect only on the date on which corrections have been made.

- (b) If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their '**One Time Registration**' profile. Such candidates alone can generate and download the Admission Tickets prior to 15 days of date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination programme itself. Information in this regard will be given to the candidates in their profiles and in the mobile phone number registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
- (c) **Candidates who have AADHAAR card should add AADHAAR card as Identity Proof in their profile.**

**11. Special Instructions to Candidates**

- (i) Candidates who receive a profile message at any stage of the selection process directing them to upload documents to prove their qualifications and other claims should do so within the stipulated time; otherwise, they will not be considered for the next stage of the selection.
- (ii) In the case of difference in Caste/Community claimed in the application and that entered in SSLC book, the candidate shall produce a gazette notification in this regard, along with Non-Creamy Layer Certificate/Community Certificate at the time of certificate verification.
- (iii) Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.
- (iv) Appropriate disciplinary action as per Rule 22 of Kerala Public Service Commission Rules of Procedure 1976 shall be initiated against those candidates who submit applications with bogus

claims of qualifications regarding education, experience etc. and are liable to be disqualified for being considered for a particular post or debarment from applying to the Commission either permanently or for any period or the invalidation of their answer scripts or products in the written/practical test or the initiation of criminal or other proceedings against them or their removal or dismissal from office or the ordering of any other disciplinary action against them if they have already been appointed, or any one or more of the above.
