- 3 If any promotee fails to report for duty in the promoted post within 15 days from the date of this order, he/she will be deemed to have not accepted promotion on his/her own volition which will entitle the forfeiture of the promotion now ordered and also the time bound grade promotion in the scale of Assistant Engineer and above sanctioned to him/her and he/she will not be eligible for the entire monetary benefits arise out of such grade promotion and the same will be recovered from him/her in lump.
- 4 Those promotees against whom disciplinary action/vigilance case is pending need not be effected.
- 5 Promotions in respect of persons whose probation have not been declared need not be effected or relieved and the details of such cases, if any, may be intiated to this office.
- 6 The incumbency of the promotees noted in this order is based on the information available in this office and changes along with other discrepancies if any should be forwarded to this office by the controlling officers concerned.
- 7 All the promotees may be relieved forthwith, after verifying their name and date of birth with Service Book and discrepancies if any may be reported to this office.
- 8 Promotion in respect of those who are on LWA and those who are under suspension need not be effected and the details of such cases may be intimated to this office.
- 9 While effecting these promotions, Sl. No. and order No. must be noted in the Service Book.
- 10 HRIS package may be updated before issuing L.P.C.


