The period of above policy expired and fresh proposals were invited from general insurance companies for insuring active sports persons for an annual sum insured of Rs.2 Lakh each in view of the increase in expenditure for the treatment of injuries. M/s.United India Insurance Co. Ltd., Thiruvananthapuram has submitted a proposal with the lowest total premium for insuring 62 active sports persons under the Group Mediclaim Policy.

Having considered the note of the Sports Co-ordinator, the Full Time Directors meeting held on 08-02-2021,

Resolved to accord sanction to insure 62 active sports persons of Kerala State Electricity Board Ltd. under the Group Mediclaim Policy of M/s.United India Insurance Co. Ltd., Thiruvananthapuram for an annual sum insured of Rs.2,00,000/- (Rupees Two Lakh only) each at a total premium of Rs.2,25,734/- (Rupees Two Lakh Twenty Five Thousand Seven Hundred and Thirty Four only) including tax.
