**ORDER**

As the litigations with regard to the application of Regulation 6 & 7 of the CEA (Measures Relating to Safety and Electric Supply) Regulations, 2010 prescribing qualifications of the Engineers, Supervisors and Technicians, culminates through the Judgment read 7<sup>th</sup>, paving way for clearance of much held up promotions to these cadres, promotions (temporary) to 122 existing vacancies in the 30% (Diploma) and 20% (ITI) quota could be done. These promotion could be effected only as temporary as the Judgment read 3<sup>rd</sup> ordering against the application of quota on cadre strength has been challenged via WA 2788/2015 by the KSEBL and the earlier promotions done in these quotas [on 21.08.2020 of 401 AEs(Ele)] were also done as temporary for the very same reason, which still remain unregularised. Though there are 122 vacancies in the combined quota, only 91 Sub Engineers (Ele) available in the gradation list of Sub Engineer (Ele) as on 31.12.2007 could only be effected as the next gradation/seniority list (provisional) as on 31.12.2016 is under strictures of not to pursue any action vide the interim order read 6<sup>th</sup>.

Accordingly, temporary promotions of 91 numbers of Sub Engineers (Ele) figured in the appended Annexure to the cadre of Assistant Engineer (Ele) are ordered subject to the following conditions.

1. The above promotions are purely provisional and ordered as per Rule 31(a) Part-II, Kerala State & Subordinate Service Rule 1958. Persons promoted temporarily as Assistant Engineer (Electrical) shall not be regarded as a probationer in the cadre of Assistant Engineer

(Electrical) or be entitled by reason only of this temporary promotion to any preferential claims for future promotion against any category in the Board. The temporary promotion will not confer upon them any right, claim, lien or seniority in the cadre of Assistant Engineer (Electrical). Training, if any, given during the period of temporary engagement does not confer upon them any claim for permanent promotion to the cadre of Assistant Engineer (Electrical).

2. The above orders are issued in the exigencies of service and in public interest.
3. As the above temporary promotion is ordered in the exigency of meeting the shortage of Assistant Engineer (Electrical), if, persons who have availed of Time Bound Grade promotion in the scale of pay of Assistant Engineer (Electrical) and above refuse to accept the temporary promotion, all benefits accrued on them consequent to the grade promotions are liable to be recovered in lump.
4. The above temporary promotions are ordered as per Rule 31(a), Part-II, Kerala State & Subordinate Service Rule 1958 and till regular hands report for duty or otherwise as and when the Board deems it necessary to terminate the temporary appointments on any other grounds whichever is earlier.
5. When regular promotions to the cadre of Assistant Engineer (Electrical) are ordered these temporarily promoted persons will be reverted to the cadre of Sub Engineer (Ele) immediately by canceling the temporary promotions or adjust against respective quota.
6. For the above temporary promotions the normal rule of pay fixation relating to temporary promotion as provided for the Clause 31(f) of Kerala State & Subordinate Service Rule 1958 will apply.
7. As per Board Order read above as 5<sup>th</sup>, temporary promotees are eligible for cadre pay with effect from the actual date of joining the promoted post.
8. Controlling officers should ensure that there are no adverse remarks barring promotion in the service book of the persons promoted temporarily. If there are any adverse remarks about the persons promoted he/she shall not be relieved and the fact be reported to this office forthwith. If any persons promoted above are presently on LWA as per Appendix XII-A, XII-B or XII-C of Part-I, KSR and have not completed minimum one year service after rejoining duty for the above purpose/resigned/under suspension the fact shall be reported to this office immediately.
9. The persons promoted temporarily as per this order shall furnish an undertaking in the prescribed format annexed to this order within a period of 15 days from the date of this order. If he/she fails to furnish the undertaking within the stipulated time limit his/her temporary promotion will be treated as canceled and stands withdrawn.
10. Before relieving the promotees from their present post, the controlling officer shall ensure that the prescribed undertaking is obtained and the same is pasted and entries in this regard are made in the service book of the incumbent concerned. Copy of the same shall be forwarded to the office of the undersigned without fail. A scanned copy of the undertaking shall be sent to the e-mail address [esthrm@kseb.in](mailto:esthrm@kseb.in)



11. Controlling officer shall verify and ensure the general and technical qualifications and date of birth before relieving the persons promoted temporarily.
12. HRIS shall be updated by the ARUs concerned.
