ORDER

The following incumbents in the cadre of Driver Grade-II (list appended) are hereby promoted as Driver Grade-I in the scale of pay of ₹36,000-76,400 (36000-1600/1-37600-2000/5-47600-2300/6-61400-2500/6-76400) in order to maintain the ratio of Drivers as per the Board Order read as 1st above and allowed to continue in the same office in which they are working at present without change of duties and responsibilities. All the promotions are subject to the conditions stipulated under.

- 1. The promotions are ordered in the exigency of service and in public interest.
- 2. The promotions are made as per the relevant rule in Kerala State and Subordinate Service Rules, 1958 as adopted by Kerala State Electricity Board Limited.
- 3. The promotion is provisional subject to the successful completion of probation in the promoted post.
- 4. He will be a probationer in the post of Driver Grade-I from the date of his joining duty in that post and the period of probation is fixed as six months on duty within a continuous period of one year. The period of probation is liable to be extended for another six months if it is deemed necessary.
- 5. His probation after joining duty, as Driver Grade-I will be governed by such rules as are in force in the Kerala State Electricity Board Limited from time to time.
- 6. These promotions shall be effected only after verifying their identity, date of birth and after ensuring that there are no adverse entries in the Service Book of the incumbents, barring promotion.

- 7. The promotions in respect of those who are placed under suspension or pending disciplinary action and those on Leave Without Allowances which will not count for service benefits shall not be effected and the details of such cases shall be intimated to this office.
- 8. The provisions of Kerala Service Rules will govern the fixation of pay in respect of the promotees.
- The incumbency of the promotees noted in this order are based on the information available from the HRIS and any change of incumbency along with discrepancies if any, should be intimated to this office promptly.
- 10. The HRIS package shall be updated accordingly.

The ratio of Driver Grade-I in Kerala State Electricity Board Limited is hereby fixed as above and ordered accordingly.
