#### ORDER

The following Overseers (Ele.) figured in the Annexure attached is promoted to the cadre of Sub Engineer (Ele.) against 50% quota earmarked for Overseers (Ele). The promotion will be purely provisional subject to the following conditions:

- 1. The promotion is ordered in the exigencies of service and in public interest.
- 2. Controlling officer should ensure that there are no adverse remarks barring promotion in the service book of the person promoted. If there are any adverse remarks about the person promoted he shall not be relieved and the fact be reported to this office forthwith. If the promotee is presently on LWA as per Appendix XII-A, XII-B or XII-C of Part- I KSR/unauthorized absence/under suspension, his promotion shall not be effected and the fact shall be reported to this office immediately.
- 3. The promotion is purely provisional under Rule 31 (a) (i) of KS & SSR 1958 as adopted by the KSEBL without prejudice to the claims of seniors if any.
- 4. Provisions of KSR will govern the fixation of pay in respect of promotees.
- 5. The promotees shall be eligible for monetary benefit with effect from the date of reporting duty in the cadre of Sub Engineer (Ele.)
- 6. If any disciplinary action/vigilance case is pending against any promotee, their promotion to the cadre of Sub Engineer (Ele) need not be effected and the fact shall be intimated to this office immediately without fail.
- 7. Controlling office shall verify and ensure the following general and technical qualifications and date of birth before relieving the person promoted.

### 8. Qualifications & Experience

(a) General: SSLC or its equivalent

## (b) Technical:

(i) Diploma in Electrical Engineering/Electronics and Communications from a Polytechnic College recognized by Government and have passed examination conducted by the State Board of Technical Examination and have undergone a course of study of 3 years.

#### OR

- (ii) Certificate from National Council for Vocational Training (NCVT) (both Regular and Private) in Electrician/Wireman/Electronics/Electronic Mechanic.
- (c) 5 years' service in the cadre of Overseer (Ele).
- 9. The promotees shall be relieved forthwith, HRIS shall be updated before issuing the LPC.
- 10. The promotees shall compulsorily attend and successfully complete the Induction level Training for new Sub Engineers (Ele.) for the satisfactory completion of their probation period in the cadre of Sub Engineer(Ele.).
- 11. HRIS shall be updated by the ARUs concerned.
- 12. Promotions in respect of the persons as Sl.Nos.1(Sri.Pramod.K) & 2 (Sri.Vinod Chandran.A.K) shall be with effect from the date of this office order Read (2).
