ABSTRACT

Revision in rates for preparation of estimates for engaging personnel on work contract basis for works of Electricity worker and Lineman in KSEBL. - Sanctioned - Orders issued.

ORDER

In view of significant manpower shortage that is existing in Electrical section offices due to large number of promotions and retirements, direction for engaging personnel on contract basis for works performed by electricity worker and linemen was issued vide order referred.

In order to prepare the estimate for the above works the rates to be taken as per prevailing government order is as follows:

Electricity worker: Rs.675/- per day

Lineman: RS.755/- per day.

However various officers especially from northern regions during the review meeting held on 30.05.2024 have informed that contractors were reluctant to quote for the works with estimates arrived using the government rates as above.

The Director (Distribution, SCM&Safety) vide note read 1 recommended that the following aspects with regard to the specific nature of works required to be carried out while engaging personnel for executing works assigned to electricity workers and linemen especially in emergency situation due to natural calamities shall be considered and suggested that a rate with 25% hike from the rates specified in government order shall be taken for arriving at estimates for the above works.

- The working conditions during natural calamities.
- The risk involved while engaging in electrical distribution network maintenance works.
- The time restrictions for executing breakdown works.
- Fuel cost incurred for traveling during the works.

Having considered the recommendation of the Director (Distribution, SCM&Safety)

sanction is hereby accorded to adopt the following rates for preparation of estimates for engaging personnel on work contract basis for works of Electricity worker and Lineman

Electricity worker: Rs.850/- per day.(Rupees Eight hundred and fifty only per day)

Lineman: RS.950/- per day.(Rupees Nine hundred and fifty only per day)

Orders are issued accordingly.
