MINUTES OF THE THIRD MEETING HELD IN THE CABIN OF THE CHIEF ENGINEER (HRM), VYDYUTHI BHAVANAM, THIRUVANANTHAPURAM WITH REPRESENTATIVES OF RECOGNIZED TRADE UNIONS, REGARDING GENERAL TRANSFER 2016, AT 10.30 AM ON 08/08/2016

The Senior Assistants in Establishment section dealing with transfer of workmen category pointed out certain difficulties in accessing data for transfer processing from HRIS. The concerned officials from IT Wing were asked to solve the issues like duplication of application, error in message intimation etc. The officials in IT wing assured to correct the mistakes immediately. A trial run of the software for transfer of any one or two small categories can be made without releasing the transfer order.

Since the data for transfer processing of Linemen could not be made accessible in the Establishment section, the Chief Engineer (HRM) authorized the Senior Assistant dealing with the transfer of Linemen to collect the data from IT wing for the time being.

Considering the unanimous opinion of trade unions, the Chief Engineer informed that regarding station change, the rules stipulated in transfer guideline will be strictly followed. Cases of all the employees who have returned to their home stations from distant transferred stations within one year by violating the transfer guidelines will be reviewed.

The following decisions were taken in the meeting.

# OVERSEER (ELE.)

- O1. All the transfer requests of Overseers (Ele.) who had requested to Ele. Circle (Rural). Trivandrum in 2015 and were accommodated at Urban circle due to non-availability of vacancies in Rural Circle will be given priority for consideration in this year. While posting to Rural Circle, first priority will be given to Ele. Division, Neyyattinkara. Ie., requests of Neyyattinkara natives who were requested to Ele. Division, Neyyattinkara in 2015, but were accommodated at Urban circle and then at Ele. Division, Nedumangad due to non-availability of sufficient vacancies, will be given first priority for consideration. The criteria will be service
- 02. In the case of transfer out from transmission wing, electrical accident victims and incumbents having serious self medical illness can be protected.
- 03. Filling of Distribution sections will be given priority.

While calculating station seniority of Sub Engineer Trainees, period of service as Sub Engineer Trainee as well as Overseer category in a particular station will be counted. Sub Engineer Trainees having trade union protection, society protection or serious self medical protection will be exempted from transerring out.

19 Sub Engineer Trainees can be transferred out and they will be posted as substitutes against the transferees from various stations to Trivandrum. The criteria will be age junior to long distant stations and age senior to short distant stations.

The Sub Engineer Trainees transferred out will be posted as substitutes in the transferred places.

Trainees and regular hands having society protection, trade union protection or self medical protection can be exempted from transferring out. 7 numbers of senior most eligible Trainees who have requested to Alappuzha can be accommodated at Harippad.

#### SENIOR ASSISTANT

Considering the opinions of the trade unions, it was decided that Senior Assistants transferred out from Kottayam can be posted at Vadakara instead of Thirur.

All éligible requests of Cashiers and Office Attendants can be considered subject to availability of vacancies.
