ORDER

The Chief Engineer (Trans.South) as per the letter read above reported that experienced electricity workers under Line Maintenance Sections on promotion as Lineman are posted to electrical sections under distribution wing. As per the present staff pattern there is no sanctioned place of lineman under LM sections. But as the services of skilled and experienced field staff with sufficient exposure in line maintenance works are essential for attending to break down as well as preventive maintenance works, the Chief Engineer(Trans.South) suggested that the present staff pattern of LM section may be revised as follows so that the services of experienced staff can be utilised:
