**ORDER**

The following Officers (list appended) are promoted to the cadre of Assistant Accounts Officer. These promotions are issued against the vacancies arising of retirement and promotions to the cadre of Assistant Accounts Officer read 3<sup>rd</sup> above. All the promotions ordered will be purely provisional subject to the conditions stipulated under.

1. The above promotions is ordered in the exigency of service and in public interest.
2. If any promotees fails to report for duty in the promoted post within 15 days from the date of this order, he will be deemed to have not accepted promotion on his own violation which will entitle the forfeiture of the promotion now ordered and also the time bound grade promotion in the scale of Assistant Accounts Officer and above sanctioned to them and they will not be eligible for the entire monetary benefits arose out of such grade promotion and the same will be recovered from him in lump.
3. The promotees against whom disciplinary action/vigilance case is pending need not be effected.
4. The incumbency of the promotees noted in this order is based on the information available in this office and changes along with other discrepancies noticed if any should be forwarded to this office by the controlling officer concerned.
5. ARU Head should ensure the date of declaration of probation of the officer in the cadre of Senior Superintendent and is recorded in the service book.

6. It shall be ensured that there are no adverse remarks in the Service Book of the promotees barring their promotion. If any adverse remarks are noticed, such persons shall not be relieved and the fact should be reported to this office promptly.
7. The promotees shall be relieved only after verifying their identity, date of birth etc; discrepancies if any should be intimated to this office with documentary evidence within a period of one month.
8. The promotions are purely provisional under Rule 31(a)(i) of the KS&SSR Rules 1958 as adopted by the K.S.E.Board Ltd.
9. Provisions of KSR will govern the fixation of pay in respect of the promotees.
10. The promotions in respect of those who are placed under suspension and on Leave without Allowances which will not count for service benefits shall not be effected and the details of such cases may be intimated to this office.
11. The promotees may be relieved forthwith, after verifying their names and date of birth with service book and discrepancies if any may be reported to this office.
12. HRIS may be updated before relieving the promotees.
